Interview Dates: June 11 - June 15, 2021

Sample Population: 1525 registered voters in the United States.

Sample Selection: Scientific online poll - stratified sample of panel respondents.

Weighting Parameters: The sample was weighted based on the U.S. Census Bureau's Voting and Registration Supplement to the Current Population Survey for registered voters in the United States based on age, gender, race, educational attainment, census region, and Hispanic ethnicity. The sample was also balanced by reported 2020 presidential vote.

This topline provides weighted percentages, as well as the unweighted N-size for the total sample. Due to the effects of weighting and rounding, figures may or may not add up to 100%. The standard deviation of the weights was: 0.263957. The maximum weight was: 2.5960043. The minimum weight was: 0.3556114. 95% of the weights were between 0.6265233, 1.6364949.

Margin of Error: The 95% credibility interval for this survey is +/- 2.6%, which includes the square root of the design effect (DEFT): 1.034228.

Respondent Language Options: In order to properly capture a representative sample, Climate Nexus provides survey respondents with the option to take the survey in English or Spanish and actively recruits respondents whose primary language is Spanish based on Census proportions. Climate Nexus uses professional survey translators to account for cultural differences and capture nuances between translations. All data is reported in English.

Poll number: pr2117

Interview Dates: June 11 - June 15, 2021

Sample Population: 1525 registered voters in the United States.

Sample Selection: Scientific online poll - stratified sample of panel respondents.

Weighting Parameters: The sample was weighted based on the U.S. Census Bureau's Voting and Registration Supplement to the Current Population Survey for registered voters in the United States based on age, gender, race, educational attainment, census region, and Hispanic ethnicity. The sample was also balanced by reported 2020 presidential vote.

These cross tabulations provide weighted percentages, as well as the unweighted N-sizes for the total sample and subsamples. Due to the effects of weighting and rounding, figures may or may not add up to 100%. The standard deviation of the weights was: 0.263957. The maximum weight was: 2.5960043. The minimum weight was: 0.3556114. 95% of the weights were between 0.6265233, 1.6364949.

Margin of Error: The 95% credibility interval for this survey is +/- 2.6%, which includes the square root of the design effect (DEFT): 1.034228.

Respondent Language Options: In order to properly capture a representative sample, Climate Nexus provides survey respondents with the option to take the survey in English or Spanish and actively recruits respondents whose primary language is Spanish based on Census proportions. Climate Nexus uses professional survey translators to account for cultural differences and capture nuances between translations. All data is reported in English.
