Methodology

Poll number: pr2405_Pennsylvania

Interview Dates: May 10th - May 16th, 2024

Sample Population: 987 registered voters in Pennsylvania.

Sample Selection: Scientific online poll - stratified sample of panel respondents.

Weighting Parameters: The sample was weighted based on the U.S. Census Bureau's Voting and Registration Supplement to the Current Population Survey for registered voters in Pennsylvania based on age, gender, race, educational attainment, and Hispanic ethnicity.

This topline provides weighted percentages, as well as the unweighted N-size for the total sample. Due to the effects of weighting and rounding, figures may or may not add up to 100%. The standard deviation of the weights was: 0.1882173. The maximum weight was: 1.3895076. The minimum weight was: 0.4321682. 95% of the weights were between 0.4587429, 1.2050269.

Margin of Error: The 95% credibility interval for this survey is +/- 3.2%, which includes the square root of the design effect (DEFT): 1.0175411. The credibility interval will vary for sub-groups and questions with split-samples.
